C Matters Arising

The Chair thanked Cllr Woodman for her work organising the latest litter pick in Trewidland on 20 April 2024, and asked her to consider widening the scope to include St Keyne for a further pick in autumn 2024.

021/2024 Councillors Reports

A Clirs Blackwell & Woodman

Cllr Blackwell reported that: will be attending a meeting of the hall committee next week when the possible sale by auction of the original site of the village hall will be discussed; will remind the committee about the council's available funding to support their purchase of solar panels; get clarification on who their choice of phone/broadband supplier will be and how it will be funded; will handover a large format portrait of His Majesty King Charles III for display in the hall (an additional portrait is being purchased for Trewidland Village Hall).

Cllr Woodman reported that: the hall committee had held its annual meeting and re-elected its Chair and officers; there will be a further games night on 26 May and a summer art exhibition from 29-30 June.

B Cllrs Hopwood & Lindsey Ellis

Cllr Ellis: thanked Cllr Woodman for proof reading the last edition that was published last week; have taken on a new advertiser for 12 months; is looking at the cost of colour covers/inserts for future editions; considering an annual survey of readers.

C Councillors Whiting and Jonathan Ellis

Councillor Whiting reported that: she and other councillors had held a site meeting with representatives from Cornwall Council Highways & Road Safety Team to discuss road safety concerns raised in relation to the B3252. These concerns arise from recent fatalities on the stretch of road near Bylane End. Cornwall Council has already installed signing and lining improvements at various locations along

the route and explained why new speed restrictions and line marking are not possible; suggested moving access onto the road from the field opposite Fursdon Cottage; agreed to cut vegetation around the cottage; will install advanced warning signs (to replace the ones currently placed by the resident farmer); will consider central hatching by Bylane End junction to reduce overtaking manoeuvres and re-siting existing signage to improve visibility; will carry out a speed survey along the route and install signage aimed at motorcyclists. Cllrs Whiting and Ellis welcomed the opportunity to have face to face meetings to demonstrate how the layout was affecting all road users.
