Cllr Kevin Shovelton Chair. Cllrs: Angela Woodman; Jonathan Ellis; Mark Featherston; Roger Cook. Also, present Parish Clerk John Hesketh and Cornwall Councillor Armand Toms. There was 1 member of the public present.

027/2024 Public Participation

PCSO Steve Edser attended to report that: crime in the parish continues to be low, and he had one instance of theft to report for May; from now until September, police patrols across the immediate area (Liskeard and Looe principally) will be increased to deter and manage instances of antisocial behaviour arising from the influx of visitors and ending of the school term; will be attending the next coffee morning at St Keyne village hall on 28 August and the Liskeard Show on 13 July.

The Chair followed up a resident's previous enquiry about a white van that had been parked close to The Village in St Keyne. A visit to the owner's home from the PCSO in Looe to give words of advice has been arranged for this weekend. PCSO Edser advised that although the vehicle is legally parked, if it made the road impassable for larger vehicles, reports can be made to the Police and a request made to move it. Photographic evidence is helpful.

Cornwall Councillor Armand Toms reported that: grasscutting along the verges at the junction of Trewidland and Horningtops by CC Highways in the last few days had been completed, but visibility for vehicles exiting the village towards Looe remained poor – he will report this again to CC Highways; concerned that the closure of the wholesale fish market in Plymouth would impact on the local economy in Looe; potholes that are being reported are being repaired promptly (see below).

Cllr Jane Pascoe submitted a written report, that: the recent road closure that affected routes into St Keyne was completed within its schedule, but residents were still able to use a reduced bus service; decisions by Cornwall Council's Constitution Committee about the way in which parish councils and objectors present themselves at planning committee appeals are under review; concerned about an increase in fly tipping as a result of restrictions on the disposal of household and DIY waste at Connon Bridge HWRC (please report incidents to Cornwall Council); was delighted to receive the 1st Liskeard Scouts into St Keyne recently who had an organised hike to Looe via this parish; privileged to have been able to attend a royal garden party in May, and a
